The Last Will and Testament of George William Connor of the Parish of Devon, Farmer

#### 28 Aug 1873

- I, George William Connor of the parish of Devon, farmer, being of sound mind but deeply impressed with the uncertainty of human life, desire to declare my last will and testament – I give and bequeath to my dearly beloved wife, Eliza, one half of the stock on the station known as the 'Jack Rivulet' - I also give and bequeath to my said wife Eliza one half of my interest in certain land in the parish of Devon South Gippsland, a hundred and twenty acres or thereabout, selected by me and recommended by a Local Land Board at Palmerston on 15<sup>th</sup> day of August 1873 and one half interest in certain land in the Parish of West Albert – a hundred and six acres or thereabouts- also selected by me and recommended by the aforesaid Local Land Board held at Palmerston as aforesaid on the 15<sup>th</sup> day of August 1873. The remaining half of each of the aforesaid selections in the Parish of Devon and in the parish of West Albert respectively I give and bequeath to my beloved Father Thomas James Connor of Alberton South Gippsland. My claim of five hundred pounds on my Policy of Life Insurance number 610 in the Australasian Insurance Company I wish to be disposed of in the following manner. One hundred pounds to be reserved for each of my children George Stanley Newton Connor and William Edward Ernest Connor and a female infant un-named Connor born on the 16th day of August 1873 until they arrive at the age of twenty one years respectively. Provided that in case of the death of one of the said children before the age of twenty-one years the sum reserved shall be equally divided between the survivors or in the case of the death of more than one before the said period, the said sum shall be given to the survivor or of all the children before the age above mentioned the said sum shall be for the use and benefit of my dearly beloved wife Eliza. The said sum of three hundred pounds to be invested in freehold property and the interest thereon to be for the use of my dearly beloved wife Eliza.

The remaining portion of the aforesaid five hundred pounds to be used to meet any claim upon the aforesaid life policy and for investment or otherwise for the benefit of my said wife Eliza. It is my desire that the operations upon said land shall be continued until it shall be otherwise determined by all the parties interested. And in the event of any dispute arising in the continuance or otherwise of the operations above mentioned on the aforesaid land the same shall be decided by an arbitration duly appointed. I hereby appoint my dearly beloved wife Eliza to be Executrix and my beloved brother Robert Arthur Henry Connor and my

beloved brother in law Alfred John Newton as Executors to this my last will and testament. And in the event of the said Robert Arthur Henry Connor and Alfred John Newton or either of them refusing to act, that my said wife Eliza shall be my sole Executrix. As witness my hand this twenty-eighth day of August in the year of our lord one thousand eight hundred and seventy three ----- George William Connor Testator Signed by the said George William Connor the Testator in the presence of us present at the same time who in his presence have subscribed our names as witnesses ------- Edward T. Newton Jnr. Cornelia A. Denham --- Sarah F. Connor

[An original duplicate of this will is held by Doreen Connor, passed down from WEE Connor. It has some large brown stains which, according to WEEC, are due to a flood. Considering that GWC made this will on 28<sup>th</sup> Aug 1873 and died on 7<sup>th</sup> Sep 1873, he must have been very ill when he wrote it. AGC 26 May 2012].

## Gippsland Times 28 May 1890

ALBERTON SPORTS. (FROM OUR OWN CORRESPONDENT.) Monday. The Alberton sports were held on Saturday, under the auspices of the local mechanics' institute committee. The day was cool, but the weather threatening, and rain fell about 4.30 p.m. The Maiden race fell an easy win to S. Hinde, of Willung, who was called upon by the committee to sign a declaration as to identity, etc. The Sheffield was won by Chas. Smith, of Alberton, off 13 yards, in 13 1-5th secs. Of the four who ran into the final, Smith and Crawford breasted the tape almost together, Connor being next and Foy fourth and last. A difficulty arose as to the placing of Smith and Crawford. It was decided they should run off, and Smith won rather easily. (First prize £11.) This win was unexpected, and gave the local bookies a "skinner." The District Plate was run in heavy rain, and resulted in another surprise, Dan Moore beating Crawford for first place by about a yard. With the money prize for the winner of the District Plate there goes a gold cup, valued two guineas, the gift of G. W. Collins. Esq., of the South (Gippsland Hop Bitters Company. J. Nicol, of Woranga, ran well, and won the Handicap Hurdles of 150, and 10 hurdles, off the 15 yards mark. J. W. O'Niel, 9 yards being second, Edgar Buckley, scratch, third. S. Hinde landed a second easy win during the day, viz., the Maiden Hurdles. The jumping contest was won' by IV. Rice 1. J. Parrot 2. Standing long jump, 10ft Sin., Rice I. Standing hop step and jump, 29ft, Rice I. Parrut was second in both events. Scott and J; Cotter were the only other competitors. The contest which was decided on points should have included the standing three jumps, but owing to the in clemency of the weather, three of four competitors withdrew, and Rice with 6 points, against Parrot 4 and Cotter 2, was declared the winner. It is expected that the net proceeds of the sports, refreshment and other booths, side shows, and concert in the evening, will be a handsome balance to place to the credit of the local mechanics' institute.

BOMBALA v. DELEGATE.

A match, Bombala v. Delegate District, was played on the local wicket on Saturday. Delegate were first to go to the wickets, Armstrong and Connor opening the batting. These two men formed strong combination, and the partnership was not dissolved until 61 runs had been subscribed. The total of the inning was 114, of which W. E. Connor contributed 38, W. Armstrong 28, W. Pink and S. Connor 11 each. M'Garrigal was most successful with the ball, and his inclusion proved a tower of strength to the visiting team, five wickets falling to his credit for the small cost of 14 runs. Hyde and Beuzeville secured three and two wickets respectively. The result of Bombala's innings was 91 runs, Hyde 21, Chapman 17, Jonas 14, and Merritfield 11, being the principal scorers. Ford and Pink did the lion's share of the bowling, and were successful in capturing four and three wickets respectively for an average of 10 runs each, S. Connor was put on at the close of the innings, and secured two wickets for four balls without the expense of a single run. Delegate again took the wickets and nine men were disposed of, the last man being absent for 62 runs. Armstrong 18, Watson 15, and Pink 10, being the principal scorers. The Delegate men only went to the wickets in a half-hearted fashion, as they considered the game over, otherwise a batter stand might have been made. Connor, who secured top score in the first innings, went in last and came out without a strike. Time was now called, and the match was decided in favor of Delegate on the first innings, who thus secured a victory by 24 runs. The players were treated to in excellent repast at Rafter's Commercial Hotelat an interval in the game.: Appended are the scores :-Delegate. First Innings.

# Gippsland Standard 6 Jan 1897

Among welcome visitors to "home and beauty" during the Xmas term, an aforetime athlete and cricketer, yclept [sic] Stanley Connor, was not the least sought after and appreciated. "Why Stan, I hardly knew you", was the greeting that kept time with the grip of welcome; but he is off again on Fortune's track. After being underground boss in a gold mine over Manaro way (N.S.W.), he decided to try the Malacoota portion of Victorian territory about six months back. He is now on his way back to Malacoota Inlet via Melbourne per S.S. Maitland, which is still in charge of the gallant Captain Leith. Mr. Connor, who speaks in glowing terms of the lake scenery, rich soil, and cheering mining prospects of the coming Eldorado, is engaged in the only quartz reef venture that is being worked up to statutory requirements; but several claims are in the shepherding stage, and will commence work the instant this very promising mine proves to be a paying speculation. [Very probably the Spotted Dog Mine which operated from 1895-1899 producing 8990z from 1635 tons of ore.] The distance from Lakes Entrance to Malacoota Inlet is about 130 miles, the trip in fair weather being simply magnificent.

The Victorians opened play, W. Armstrong, and E. Connor taking the wickets, to the bowling of Mahonev and Hyde, and succeeded in putting together 11 and-14 respectively before they were disposed of. Ford and S. Connor succeeded Armstrong and E. Connor, and put together 23 and 13 before retiring. The balance of the team only made small scores. At the conclusion of the innings of the Victorian an adjournment was made for lunch. On resuming play the Bombala men took the wickets; Hyde and Telfer being first to bat, Telfer being bowled by S. Connor after making 5. Cook then joined Hyde, and after some good cricket Hyde, who had put together 21 was given out 'leg before'. Mahoney raplaced Hyde, and a good stand was made, Cook eventually being bowled by Armstrong, after making 14; Mahoney after adding 17, being caught by Armstrong. At this, stage a rot set in, and the next five wickets fell for 4 run. The 'dark, 'en' then joined Dunne and they, with the assistance of a few byes succeeded, in totting the score up to 79, when Dunne's wicket was taken. Hyde was most successful with the ball for Bombala and Ford for Victoria, each securing six wickets. The fielding of the Bombala men was good all round, while that of some of the Victorian was somewhat faulty. # Australian Town and Country Journal 21 Feb 1906

Eden Show. (BY OUR SPECIAL REPRESENTATIVE.)

Although held under adverse conditions as far as the season is concerned, the fourth annual show of the Eden Exhibition Society, which was held on February 14 and 15, must be classed as a very satisfactory exhibition. Bearing in mind also that the society is only a young one is an additional reason for the pronouncement. Of course, the recent spell of dry weather seriously affected the quality and quantity of the exhibits in the agricultural classes, but, notwithstanding that fact, the entries were very creditable. The officials of the society deserve great credit for the excellent arrangements made for carrying out the various events, and, partly as a result of that, the ring contests were greatly appreciated, particularly on the second day of the show, when a large number of visitors from the town and district were present. The office bearers for the show were: Messrs. W. J. Moor head (president), C. E. Walcott and W. I. Swinnerton (vice-presidents), J. A. Boyd (treasurer), and William Ryder (secretary), while the committee consisted of Messrs. G. R. Phillips, A. I. Nicholson, John Hines, S. Cole, P. H. Phillips, J. Morgan, T. J. Ramsey, P. McCloy, R. Bruce, W. A. Robertson, P. E. Rogers, R. H. Cook, W. E. Connor, J. P. Barlow, A. E. Dowling, J. T. Mitchell, and Robert Coward.

Coming to an analysis of the exhibition, it must be admitted that the horse section rightly claimed the first consideration, the number and quality of the exhibits being exceedingly good. In the blood classes, Mr. R. A. Cough ran's (Pambula) Maori Lad secured the prize for blood stallions 3yrs and over. Maori Lad is a fine animal, being by Maori Chief out of Violet, by Muir Lad out of Polly, by Clinker. Master D. H. Binnie was a very successful exhibitor in horses, his Chester securing no fewer than five first prizes, viz., hackney (up to 14st), two in heavy buggy horses (15.2 and over), and two in double harness, including the president's special. In addition to these, Master Binnie also exhibited a blood gelding, 2yrs and under (first prize); blood gelding, 2yrs and under 3yrs (first prize); draught gelding, 2yrs and under 3yrs (first prize); and a trotting horse in harness, open to all comers (first prize). Master C. Collins secured first and second prizes in the pony high jump (14h and under), also first in pony hacks (14h and under), and Mr. Robinson's special for hunters (14h and under). Mr. V. J. Tarlinton, of Bega, exhibited his Morano, which secured first for lady's hackney and light hackney, being ridden by Miss Read. Miss Read also gained first prize for lady rider and lady rider over jumps.

In the cattle sections the exhibits, though not numerous, were generally speaking, very good. Among the principal exhibitors were Mr. E. T. Smart, C. Downton, A. Fourter, G. A. Fourter, S. Cole, and the Hopkins Estate. Mr. Smart, of Lochiel, near Pambula,' gained first prizes for Shorthorn cow, Durham cow, Short horn bull, for pen of three poddies, and also seconds for Ayrshire cow and Jersey cow. Mr. Smart, who is a native of the Milton district, and who has been at Lochiel for nine years past, is at present milking 120 cows. Mr. Smart, however, intends to leave Pambula for Queens land shortly, having recently purchased a property on the Darling Downs. Mr. C. Downton, of Eden, was successful in the class for host bull for dairying purposes with his 10 months old Jersey Paddy, Mr. Wren (of the Kameruka Estate, Bega), who was a visitor to the show, remarked that Paddy would be worth taking to the Sydney Show, it being unusual to get a bull with all his points. In addition to this first, Mr. Downton obtained second prizes with his Jersey and Guernsey crossbred bull King Edward, and Jersey bull King Sam. Mr. A. Fourier, of Nethercote, Eden had three cattle on exhibition, sectoring with them two first prizes, viz., for Short horn heifer under 2 years, and for Jersey cow, the latter being gained: with his cow Princess. Mr. G. A. Fourter exhibited the first prize Jersey heifer under. 3yrs, while Mr. S. Cole showed the first prize Ayrshire cow, and obtained seconds for Short horn cow, and for fat cow, the first in the latter section going to the Hopkins' Estate. This estate also secured first for fat bullock. Mr. A. H, Rugg and Messrs. Flower Brothers were also successful exhibitors in the cattle section.....

The sheep exhibits wore confined to those shown by Messrs. Connor Brothers, of Broad water, Eden. Although sheep-breeding does not exist on a very large scale in the Eden district,

I telegraphed to Sydney for a 16' barrow with mountings and asked Mr. Downton to send it to you by this morning's coach; you should get it with this. I suppose Hyde has forwarded the pick and shovel. We are all well but tired of dark and rainy weather. We had 219 points yesterday, and 117 this morning. I think the wet has interfered greatly with your work. Have not been in town or seen anyone for more than a week so have no news beyond hearing that "Uncle Charlie" is expected home on Tuesday. Mrs. Boyd joins me in kind regards. [E.R. - Uncle

## JA Boyd diary 29 Jun 1907 Letter # 99

Thanks for your 2 letters. I hope the assay of the reef you found will turn out well or else that you will strike some gold in the claim as I can only carry on a few weeks more at the present rate. The claim has cost me already nearly £100 (Hungerford's account was £15-10-11) although I should be reluctant to chuck it up. I can't afford £5 every week. Lubbe has an idea that some alluvial gold would be got to help pay work expenses. I am glad the stores at Maxwell's came in handy. The weather has been fine lately but very cold. On every morning the little creek between this and Walcott's was frozen at 10 o'clock this morning. Walcotts came home on Tuesday. Mrs. Stone not yet returned so Miss Langley is still in Eden. Flower Show (save the [?]) yesterday and today. Mrs. Olly Harrison went to Sydney last Wednesday. I have not been in town this month. No news has come this way - since tennis finished we have no visitors. Mrs. Boyd joins me in kind regards.

I know nothing of Mitch's arrangements with "Stan" but hope the farm is in Ella's name. I have always disliked the match, at the same time it will be rough on Ella to find that she has married a man who is liable for about £1000. Sorry to hear from Archie that Mrs. Bradley was not too well. Yours truly, J.A. Boyd

<u>Re</u> Connor's mortgage. Beyond the paragraphs in the newspapers I have no information about Mitch's will, but your letter seems to imply that Ella can only handle the interest of the money left her. There are two questions. 1<sup>st</sup>. Does Ella know that Connor is liable for a large sum(?) and if she did, would it make any difference? I have no hesitation in answering NO to the second. Connor is a good stamp of a man, but though over 40(?) he has accumulated nothing but debts and to marry a woman with money is a mean way of making (as he hopes) the rest of his life comfortable. Ella never writes to me so I do not feel called upon to interfere but shift the burden on your shoulders – you must stand "in loco parentis".

## Pambula Voice - Friday 3 October, 1913

#### Death

On Saturday morning last there passed away at **Broadwater**, **Pambula**, Samuel Geekie Robinson, at the age of 42 years, after a short illness, hemorrhage of the lungs being the immediate cause of death. S.G. Robinson started out in life with a very promising future. In 1887 after serving nine years as an officer in the Union Bank of Australia Ltd., he was so much thought of by the general manager for his past service that the bank voted him three months salary on his retirement.

In 1900 he decided to try his fortune as a soldier in South Africa, whither he went with the N.S.W. Mounted Rifles, 2<sup>nd</sup> Contingent. Colonel Kenneth MacKay, in writing to deceased said, Ï think it was very plucky of you to have gone out as a ranker, when your position and education certainly entitled you to a commission. I can with every confidence recommend you to the Military Authorities for a position of responsibility and trust." When granted his certificate of discharge from the Imperial and State Contingents in the South African Boer war, he was handed the Long Service Medal, also Clasp, "Wettbergen Diamond Hills". It would appear that the trying climate of Africa somewhat broke up, what was a healthy constitution, and he subsequently led a retired life. **During the past eighteen months he had charge of the Broadwater property, Pambula**. His affable, free and easy manner won him many companions, and general regret was expressed at his sudden demise.

A brother of deceased is manager of the Commercial Banking Co. of Sydney, at Toowoomba (Q) while another brother is a solicitor at Forbes, also **Mrs. A.E. NEWTON**, of Bombala, and Mrs. R.W. Dawson of the Bank of N.S.W. Braidwood, are sisters. The funeral took place on Monday when the remains were interred in the Church of England cemetery. The Rev. N. Gardiner of Kameruka officiated at the graveside. The funeral arrangements were in the hands of Mr. Job Koerber.



Dearest one,

I wish you were here in a way but in others I don't. It is very depressing to see the old man so helpless and all the constant work it entails. He is a bit better to-day and seems to recognize everyone. He is a bit of a problem as he has no control of his water and the bed is continually wet. It is very hard to change his bed which must be done about four or five times a day and up till now there has been no sun to dry the washing. To-day is sunny.

......Got home about eight o'clock and after being with Dad for a while, he recognised me and seemed to brighten a bit. .....

Came home as Em was going out and there always has to be someone here with Mum or two anyway. I have just had lunch and changed Dads pyjamas and bedding. That is about all that has happened to-day. .....

If Dad stays as he is to-day I will fly back on Sunday as I cannot stop here indefinitely when it may be weeks or even months but I will let you know by the weekend.
