DR. KEITH WHITING'S MARRIAGE.

On the afternoon of Wednesday, November 22nd, Dr. Keith Whiting, eldest son of Mr. and Mrs. W. Whiting, was married to Miss Mary Smyth, daughter of Mrs. J. Kane Smyth, of 'Marmion,' Waverley. The bride, who was given away by her brother, Dr. Jack Smyth, wore a lovely gown of white satin, trimmed with Brussels and rose-point lace, wreath of orange blossoms, and a large veil. The bridegroom's gift was a gold watch bracelet. The bride was attended by five brides maids — Miss Marjorie Smyth, chief bridesmaid, and Miss Sybil Smyth (sisters of the bride), Miss Vera Whiting (sister of the bridegroom), Miss Nellie Crouch [*later Mrs Jack Smyth*], and Miss Molly Parks. They wore dresses of white pin-dot muslin, trimmed with alternate bands of finest malines lace and narrow pale blue satin bands, wearing sashes of pale blue satin; hats of twine-colored Tegal straw, trimmed with pink and maize-colored roses and foliage. The gifts of the bridegroom to the brides maids were gold signet rings, and bouquets of pink roses, tied with streamers of blue ribbons. Dr. Furber acted as best man.

The marriage ceremony was celebrated at the Grahame Memorial Church at Waverley, Rev. J. Macaulay officiating. The church had been exquisitely decorated for the event with flannel flowers and red carnations, November lilies and tall palms, with a large floral wedding-bell suspended over, the heads of the bridal party. The hymns sung were 'The Voice that breathed o'er Eden' and 'Oh, perfect love.' A lady organist presided at the organ, and while the register was being signed, Mr. Tom Middleton sang 'A song of thanksgiving.'

The reception was held at 'Marmion,' where the breakfast was served 'in a large marquee on the lawn. The one toast proposed was that Of "The Bride and Bridegroom," by Rev. J. Macaulay. The bridegroom responded. The table where the bridal party sat, and on which was placed the wedding cake, was decorated with sweet peas. The other tables were decorated with red and pink carnations. Dr. and Mrs. Whiting received the congratulations of their friends in the drawing-room, which was beautifully decorated with flannel flowers and pink roses, and the wedding presents were displayed in the ballroom, which was profusely

decorated with flannel flowers and red carnations. Dr. and Mrs. Whiting left by motor for Sutherland, and from there they will continue a motor trip during the honeymoon. The bride's going-away dress was of powder blue coat and skirt, with floral silk collar and facings, and Pierrot hat of same shade, trimmed with striped ribbon.

Mrs. J. Kane Smyth (mother of the bride) wore royal blue, with over-dress of black ninon; black hat, trimmed with ostrich feathers, and carried a bouquet of blue delphiniums. Mrs. Whiting (mother of the bridegroom) wore sapphire blue, with overdress of black net and lace; black hat, with ostrich feathers, and carried a bouquet of flowers of the same shade as her dress. Mrs. Phipps Waugh (sister of the bridegroom) wore lime colored ninon, with beaded trimming and, hand-embroidered yoke; green straw hat, trimmed with sapphire blue ostrich feathers, tipped with black. Mrs. Leslie Moore (sister of the bridegroom), creme ninon, with guipure, button and pearl trimming; hat of same shade, with satin ribbon trimming, and bunches of pink and mauve flowers. Mrs. Bennett (aunt of the bridegroom), reseda crepe de chine, gold embroidered net, and jewelled trimming, with toque of white tulle, veiled in black figured chiffon and pink roses. Miss Helen Bowman, Wedgwood spotted foulard, with black satin trimming; hat of same shade, trimmed with pink and mauve flowers. Miss Maclean, pale blue and pink floral muslin, blue satin sash; black hat, with lace quill and magenta rosebuds. Miss Davidson, brown ninon, amber colored Pierrot hat, trimmed with black velvet and pink roses. Mrs. Palmer, black crepe de chine, lace coat, white feather boa. Mrs. Davidson, black and white striped foulard, jet trimming; black hat, brimmed with feathers. Miss Teece, mauve ninon, trimmed with amethyst ninon, the border edged with rosebuds, made of satin, toque of same shade; Mrs. Robt. Sands, navy ninon over gold, gold embroidered trimming, Tuscan hat, lined with black, with wine-colored flowers; Mrs. Richard Teece, black and white, striped foulard, cerise trimming, black hat, with white ostrich feathers; Mrs. J. Sands, nattier crepe de chine, hat of same shade, trimmed with pink stocks and lilies of the valley; Mrs. Charles Maclean, reseda crepe de chine; Miss Ireland, coronation ninon; Mrs. Edward Rich, amethyst ninon, rouleau trimming, toque of same shade, trimmed with ostrich feathers; Miss Mackay, grey voile, tucked, Tuscan hat, with wreath of pink roses; Miss Car tor, white net, inlet with lace, guipure border, pink satin underskirt and pink sash, maize-colored hat, trimmed with pink, tulle quill, and bunch of small roses; Mrs. Johns, dove-colored coat and skirt, with blue and black striped piping, hat of same shade, trimmed with vari-colored satin apples; Mrs. Sly, brown, ninon over electric satin, passementerie trimming, brown tulle toque, with foliage; Miss Meekel, champagne voile over gold satin, piped with black, green hat, with black ostrich feathers; Mrs. Barraclough, black ninon, trimmed with embossed net; Mrs. Pratt, white embroidered muslin, black hat, trimmed with pink roses and forget-me-nots; Mrs. George Helicar, dove colored ninon, trimmed with gold net and but tons, tint of same shade, trimmed with brown and pink roses; Miss Keaton, white muslin, trimmed with Irish crochet, green hat. with pink and black flowers; Mrs. Macaulay, black ninon over white, handsome lace scarf, black lace toque, trimmed with white ostrich feathers; Mrs. Parker, white muslin, lace trimming, green hat, blue and pink flowers; Miss M. Wenty's Record Ball. For the Children. And Red Cross Funds. Always an energetic and up-to-date body, Wentworthville branch of the Red Cross Society was very greatly in evidence on Monday night, May 28. Under its auspices and supervision a fancy dress ball and euchre party were held in the Peace Picture Palace in aid of Wentworthville's cot at Renwick Hospital, and its own fund. The attendance was splendid, quite 300 people taking part in both sections 'of the function, although the ball dominated greatly so far as attraction was concerned. The theatre was decorated with green bushes laced with red paper streamers. The lights were veiled with the same color, and created a soft effect, although not detracting from the brilliance of the beautiful costumes worn by the lovers of Terpsichore. Flags and patriotic emblems were artistically arranged around the walls, while the picture screen carried a' groat red cross, which unmistakeably demonstrated the nature of the gathering. When entering the hall, it immediately became evident that a great deal of earnest, zealous work had been done, and, on looking for the source, it ,as found that those responsible in the main were the members of the local Red Cross branch, viz., Mrs. E. MRS. E. R. H. WAUGH.

Mrs. Elizabeth Rose Holden Waugh, widow of the late Dr. Isaac Waugh, who died at her residence, Tara, George-street, Parramatta, on Saturday last. In her 86th year, was one of the oldest residents of that town. Mrs. Waugh was a daughter of the late A. H. McCulloch, a prominent Sydney solicitor of earlier days. Dr. Waugh figured in the thrilling incidents connected with the shooting at Clontarf, by a demented man, of the Duke of Edinburgh, brother of the late King Edward. Dr. Waugh was a young naval surgeon at the time, and he was the first medical officer to go to the Duke's aid. He succeeded in stanching the flow of blood, and attended the Royal patient until the arrival of his Royal Highness' personal medical attendant. Mrs. Waugh was married at St. Mark's, Darlinghurst, in 1867, and in 1873 re-moved, with her husband, to Parramatta, where the remainder of her life was spent. She was a warm supporter of the Church of England. Prior to the interment an impressive service was conducted in St. John's, Parramatta, by the Rev S. M. Johnstone, assisted by Rev. H. W. Bader (All Saints', Parramatta). The chief mourners were Dr. R. A. Phipps Waugh (son), Miss Joan Waugh, and Miss Cassia Waugh (daughters). Mrs. Waugh (daughter-in-law), Mr. Bryan Waugh (grandson), Mr. E McCulloch (cousin), Mrs. B. Du Faur, Mrs. Basil Fairfax Ross, Mrs. E. Styles, and Miss Ethel McCulloch (nieces).

Mr. Leonard Dodds Death in Hospital MOTORING ACCIDENT The death occurred at Parramatta Dis-trict Hospital on Tuesday of Mr. Leonard Dodds, of "Widemere," Wentworthville, and formerly a prominent figure in mining circles in this State.

A week previously, while driving from Parramatta towards his home, Mr. Dodds' car overturned and he received injuries which caused his death. It is assumed that Mr. Dodds, who suffered from heart trouble became suddenly ill and lost control of the driving wheel. Mr. Dodds had had a wonderful experience in mining and financial matters, and his fund of anecdote made him a most interesting raconteur. He was exceedingly popular in this district where during ten years' residence he had made numerous friends. He was a son of the late John Dodds, R.N., and was born at St. Leonards in 1861. At the age of 26 he was a company promoter, and was associated with the early development of the Broken Hill mines. He was responsible for the flotation of Broken Hill Central Mining Company, and was also associated with the Nymagee Copper Mine, the Cobar mines, and gold-mining companies at Sunny Corner and Girilambone and elsewhere. Mr. Dodds retired from business about ten years ago, and took up residence at "Widemere". He was an art collector, and his display of Streeton's earlier paintings have been described as the best in existence. Deceased is survived by a widow, three sons and a daughter. The funeral took place on Wednesday, and prior to the interment in the West-ern-road Cemetery a service was con-ducted at All Saints Church of England by Rev. G.F.P. Manning. HUSBAND'S STORY

Dundas Shooting Inquest SYDNEY. Tuesday.

The shooting of Mrs. Rona Solo mon, 23, at Spurway-street, Dundas, on the evening of December 27, was inquired into to-day by the Parra-matta District Coroner. Mr. Richard son Clark.

Sidney Howard Solomon, 25, husband of the woman, who has been charged with murder, was present in court in custody. A fair, thick set man, he appeared to be very nervous. Plainclothes constable Sly said that he saw Solomon at the Parramatta Station on December 28. "I wish I could think where I threw that gun," he said. "She told me that I was not the father of the child. I love her and knew I was the father, and I was looking forward to it to come. I went there to beg of her to come home, and when she told me I was not the father I was mad. I don't remember after. The next thing I remember was when the police took me in the car." LETTERS TO WIFE

Constable Sly added that when he searched Solomon he found in his pocket two letters to his wife. Next day he saw Solomon at the gaol and he showed his some letters signed by him, and he admitted having written these to his wife. Dr. E. C. Hall, Government Medical Officer at Parramatta. said that on December 27 he held a post mortem on the body of Mrs. Solomon. She would had had twin male children shortly. One of the bullets had entered her head above the ear, another below the ear, and the third at the back of the head. One had passed through her brain. The bullets must have been fired at close range, because there were powder marks around the wound. At 10.30 Dr. Hall saw Solomon at the police station. He smelt of liquor, but he was quite sober. He said that he had been drinking ail the morning and could not remember what had happened during the even ing. If he had been drunk at 6.30 he could have sobered up by the time witness saw him. The bullets were fired from behind and could not have been self inflicted. Mrs. Solomon was dead when she reached the hospital. Dr. Cedric Whiting said that he was called to the hospital about 8 p.m. and had performed a Caesarian operation in order to save the twin babies. Artificial respiration lasting three-quarters of an hour had been carried out on one of the infants, but it failed to save it.

MOTOR-CYCLIST ACQUITTED Sequel to Collision "LOOKED DOWN TO CHANGE GEAR" A collision between two motor cycles at Canley Vale on February 28 had its sequel at the Parramatta Quarter Sos: sions on. Tuesday, when John William Blair was charged with having caused bodily haran to Charles Lcddell Wolter by wanton driving. Mr. Walker appeared for the accused, who pleaded not guilty., .Constable Little said that about 7.30 p.m. on February 28 he ,was called to Liverpool-road, Canloy Valo, where lie saw two motor

cycles locked together.. One had a sidecar attached. About four hours later, he saw the accused at the residence of a man named Kennedy, about two miles from the scene of the accident. Wolter, who lives in Regent-street, Sydney, said that he was about a hundred yards away when he first noticed the motor cycle and sidecar coming in the opposite direction. "They crossed over to my side of the road and back two or three times," the witness said. "Just before they got to me they swerved and came straight at me. I remembered no more until I woke up in the hospital about five days later." William Lang, poultry farmer, in front of whose house the accident occurred, said that he saw the motor cycle and sidecar trying to pass a lorry, and travelling between forty and fifty miles an hour. "Just before they got in front of my place," the witness said, "I saw a motor cycle coming in the opposite direction. The accused got over to his wrong side of the road and collided with the other cycle, which was off, the asphalt on its correct side." Evidence of having heard the crash: and of having seen the two cycles on the side of the road was: given, by John Moore, who also lives in Liverpool-road, Canloy Vale. "Jack Carrington Smith, ambulance officer at Liverpool, expressed the opinion that the accused, when he was at the scene of the accident, was under the influence of liquor. He added, however, that the condition of the accused could have been caused by shock. Ernest Allen Cooper, of Lakemba, who was in the sidecar when the collision occurred; said that the accused was passing a lorry and that when he saw the other motor cycle, it was too late to avoid it. The witness added that he and the accused had had one drink each. Blair, a breadwinner, who lives at Bankstown, said that he had only had the cycle and sidecar twelve days when the accident occurred, and that he had a learner's permit. "I went to pass another vehicle," he said. "I looked down to change the gear, and that's the last I remembered until a man named Kennedy was giving me a drink. I had only been on the bike five times and I couldn't change the gear without looking down. I did not see the other motor cycle approaching me." Dr. Cedric Whiting gave evidence of the tests usually applied to ascertain whether a person was under the influence of liquor, and stated that the condition of a man suffering from shock could be confused with the condition of a man under the influence of liquor.

result of living on food supplied under the dole system. Death, he said was due. amongst other things to hemorrhage of the brain and chronic Bright's disease.

Dr. Cedric Whiting said that when he examined Tapley on July 22 he I was definitely under-nourished, though there were no signs of starvation.

The coroner returned, a verdict in accordance with the evidence of.. Dr.Hall. Insufficiency of food, he added, did not contribute to his death, as it was thought to have done.

Death Under Anaesthetic Woman's Sudden Collapse Suddenly collapsing while under an anaesthetic, Violet Ella Blanche Denzel (33), of Northmead-avenue, Northmead, died at the Parramatta District Hospital on October 11. An inquiry was held by the district coroner (Mr. H. Richardson Clark) at Parramatta last Thursday. The evidence disclosed that Mrs. Denzel underwent an operation for the removal of the gall bladder. The operation was performed, and the stitching of the wound was about to be done, when the patient suddenly collapsed, and her heart stopped beating. All efforts to restore her were unsuccessful. Evidence of having administered the anaesthetic under the supervision of **Drs. Waugh and Cedric Whiting** was given by Dr. Kingsley, one of the resident medical officers at the Parramatta District Hospital who said that although there appeared to be no organic disease of the heart, the patient seemed to be suffering from the effects of toxemia. It was essential to operate. When she collapsed -and she collapsed very suddenly -the patient had been under anaesthetic for about an hour and a half. **Dr. Cedric Whiting** said that the proper anaesthetic was used, and that it was administered in a proper and skillful manner. When the patient collapsed everything was done to restore her. The cause of death was myocarditis aggravated by absorption of poison in the system from the septic gall bladder. Mrs. Johnstone, sister of the deceased asked why the patient's strength was not built up in the hospital before the operation was performed. "She was getting worse all the time," **Dr. Whiting** said. " If the operation had been delayed, I have no doubt that she would have died from blood poisoning from the septic gall bladder." **Dr. Waugh**, who performed the operation said that the deceased had been suffering from inflammation of the gall bladder for the last eight years. " The only way to restore her health was to operate" the doctor said. The witness said that the anaesthetic was properly administered, and that, when the patient collapsed, everything possible was done to restore her. Regarding the question asked by Mrs. Johnstone, **Dr. Waugh** said that the patient did not require building up by food. If she had not been operated on, she might have died at any time. Mrs. Johnstone: You have been attending Mrs. Denzel for a long time. Why did you not operate on her before? An operation was suggested to her many times, but she didn't like the idea of an operation. **Dr. Waugh said** that, in twenty six years, this was his first experience of death under anaesthetic. The coroner found that the death was due to the anaesthetic and poisoning of the system from the septic gall bladder, that the anaesthetic was skillfully administered and the operation skillfully performed, and that, when the patient collapsed everything possible was done to restore her.

In 1897, after he had been elevated to the rank of sergeant, he was selected as one of a detachment of Lancers to represent his State at Queen's Victoria's jubilee celebrations in London. He served at the front with the A.&O., with distinction, as did his partners, **Drs. Keith and Cedric Whiting**. Naturally, he has a very complete stock of Digger yarns. For some time he has been a Parramatta alderman and has found the job not unlike that of the football referee. Had he so desired he might have been Mayor for several terms. Dr. Waugh plays golf a little; there was a time when he played quite a lot. He found, however, that he could not attend a race meeting and play golf on the same Saturday afternoon-so he gave up golf. As a member of Parramatta Rotary Club he has delivered a few interesting talks on his trips to the East. Of course, he did not tell all. He agrees with Cowper that: "Variety's the very spice of life, That gives it all its flavor."

GAOL SENTENCE FOR H. Y. THOMPSON

4 YEARS PLEADED GUILTY

CLIENTS' MONEY £3407 INVOLVED

HAROLD YORK THOMPSON, 35, who had practised as a solicitor at Parramatta, was sentenced by Acting-Judge Edwards at the Quarter Sessions to-day to four years' imprisonment. Thompson had pleaded guilty to misappropriation, forgery, uttering and false pretences, involving a total of £3407 of clients' money. **Mr. S. Redshaw (Thompson's counsel)** called Dr. Cedric Whiting, of Parramatta, to give evidence as to the character and general health of the accused. Dr. Whiting said he had been accustomed to meeting Thompson several times weekly, and had noticed during the past nine months that -he had become very worried and distracted. As nil illustration. Dr. Whiting mentioned that Thompson, who was formerly a particularly good card player, had lacked the necessary power of concentration, with the result that he had made the most elementary mistakes. **The accused, the witness added, had been held in high esteem by his friends and acquaintances.** Story of Launch Detective-Sergeant Clifford stated that on May 8 Thompson disappeared, and it was later ascertained that he and his brother had hired a launch, ostensibly to go fishing. The launch was subsequently found abandoned on the Hawkesbury River in circumstances which gave rise to a fear that the Thompsons had been the victims of foul play. An extensive search was commenced, and the Thompsons were ultimately located at Broken Hill. The accused was arrested in Adelaide. The prisoner's first lapse, said Clifford, occurred in August, 1933, but

since January of this year the defalcations covered an additional sum of £2000. In all, the defalcations totalled £3407. Meeting Claims Mr. Redshaw said the firm of solicitors with whom Thompson had been associated had decided without quibble or delay to meet out of their own purse all claims that would ensue from clients in respect of the defalcations carried out by Thompson. Despite the firm's financial loss through the defalcations of Thompson, said Mr. Redshaw, they joined with counsel in an appeal to the Judge that the sentence be made as lenient as possible.

WORKMAN FATALLY INJURED

Collapse Of Wall "ACCIDENTAL" SAYS CORONER An extra strong gust of wind spelt tragedy for William Richardson Robson (58) on September 2, when he was buried beneath the debris of a wall which was blown down at the corner of Church and Phillip-streets, Parramatta. He died in Parramatta District Hospital the following day. A verdict of accidental death was returned by the district coroner (Mr. G. R. Williams) on Thursday, when witnesses at an inquiry stated that in ordinary circumstances the wall was perfectly safe and that it appeared to be solidly built. Reconstruction and demolition work was being carried out at the time. The wall was an old one. Charles Frederick Francis, laborer, employed by Webb Bros., said that he was working on the second floor of the front portion of the building at the time of the accident. Robson was cleaning bricks on the same floor. It was a very gusty day, and a heavy gust of wind came just before the accident. It was a much stronger gust than had been usual that morning. "There was absolutely no warning at all," Francis told the coroner. "I had my back towards the wall and was partly buried under it. My mates ran over and pulled the bricks off me. We looked around for the old chap, but didn't see him. I thought he had jumped over the wall with fright when he saw it coming at him. Then we began to look for him, and found him lying where he had been standing. We pulled the bricks off him." Francis told Sergeant Malley that the wall was not propped in any way. NO CRACKS. Mr. Sproule (for Webb Bros., builders): Were there any cracks in the wall or anything to lead you to think it was insecure?—None whatever. Did it appear to have been solidly-built wall?—Yes Wilfred Norman Johnson said that, after the wall collapsed he could see only portion of Robson's trousers. Sergeant E. J. Stephenson (Parramatta), who went to the scene shortly after the accident, said that Robson's body was partly covered by concrete and debris. His head appeared to be crushed on the right side and at the back, and his right leg appeared to be broken. An examination indicated that a portion of a nine-inch wall which had collapsed was sixteen feet long and nine feet six inches high. A very strong north-westerly wind was blowing and had been blowing all that morning, said the Sergeant. William John Knight, foreman in charge of the work, described the wall as "a remarkably good wall" and said he had not considered that Robson was risking any danger. The foundation of the wall was very strong he said. Under any ordinary conditions it was perfectly safe. There was a sudden gale at the time of the collapse, he told Mr. Sproule. Dr. Cedric Whiting (Parramatta) expressed the opinion that the cause of death was shock resulting from fractures to the skull and right leg. Sergeant J. H. Malley appeared to assist the coroner

DIED OF DIPHTHERIA, TREATED FOR QUINSY

Would Not See Doctor

"Had this woman been seen early and received proper treatment, she probably would have recovered," said Dr. Cedric William Whiting in Parramatta Coroner's Court to-day, at the inquest on Mrs. Ada Keech, 44.

Mrs. Keech died of diphtheria in an ambulance while being taken to hospital. Evidence was given by a bio-chemist that on her husband telling him she had quinsy, he gave him a quinsy mixture.

Dr. Whiting said that on November 28 (the day of her death), he received a call to Seven Hills, and there saw Mrs. Keech desperately ill with diphtheria. Maurice Raymond Keech said that his wife became ill after the birth of her first child in 1928, and later developed Bright's disease. She was treated by several doctors and was at the point of death in 1930. when she gave birth to a stillborn child. She rallied somewhat but later In the same year, three doctors said that she could not live more than six months. About this time, she visited R. W. Small, a bio-chemist in the city. After treatment, her condition improved considerably. About three months ago, she got relapses of her old complaint and again saw Small, to whom she made her last visit on November 18. The following day she complained of sore throat and gargled it. Next day there was a good- deal of swelling but she refused to see a doctor. He himself saw Small, who altered her medicine. Keech said that he asked his wife on' several occasions to see a doctor but she refused. Had Quinsy Before Finally he called **Dr. Whiting**. Replying to the Coroner (Mr, G. R. Williams). Keech said that at first his wife thought she had mumps, but later believed It to be quinsy, a complaint she had had twice previously. He told Small this and Small gave him fresh medicine. "Blood Very Poor" Rowland Wesley Small said he was a fellow of the United Practitioners' Association of Australia, registered in Victoria, and president of the Biochemists' Association. He had treated Mrs. Keech for liver and kidney complaints for about seven years, and she always had responded to the treatment. When he last saw her on November 15, her blood was very poor through acid. When Keech saw him on November 21, he said that his wife was certain she had quinsy. He, therefore, gave a quinsy mixture. **Dr. Whiting** (.recalled) said he had heard that Mrs. Keech 's uncle was buried on the day of her death. Small: Do you not think that the shock of the death and of her learning that she had diphtheria caused her death?— No. Returning a finding of death from diphtheria, the Coroner said he had no doubt that if Mrs. Keech had been seen by a qualified medical practitioner, her complaint would lave been diagnosed earlier and per-! haps successfully treated. "A husband is bound to provide proper medical attention for his wife and children," he said. "In this case, this does not appear to have been wilfully refused, "The husband had tried to persuade his wife to see a doctor, but she was satisfied that she was suffering from quinsy, a complaint she had had before, and naturally he believed her."

'DREADFUL NEGLECT' MERRYLANDS GIRL'S DEATH NO MEDICAL AID Shocking circumstances surrounding the death of Bertha May Simpson (23), of Myall-street, Merrylands, were revealed at an inquiry held by the district coroner (Mr. G. R. Williams) at Parramatta yesterday. Evidence disclosed that the girl received no medical attention, and that she died in filthy surroundings. "This," said the coroner, "is a dreadful case of neglect. ... Nobody seemed to care." The girl, whose parents are living apart, was employed as a domestic servant by Mr. and Mrs. Silverstone, of Merrylands. At the inquiry, Mr. N. S. Rishworth appeared for Mr. and Mrs. Silverstone: Detective-Sergeant McCarthy for the police. John Ernest Simpson, of Sydney road, Granville, said that he was living apart from his wife and family. Evidence of having visited the girl's home with Sergeant Swan about 11 a.m. on August 9 was given by Detective-Sergeant McCarthy, who stated that he said to Mrs. Simpson, "I understand your daughter Bertha passed away this morning. Had she been treated by a doctor?" Mrs. Simpson replied, "No. I rang up the doctor, but he wouldn't come. Dr. Sheldon came this morning, but he was too late. She was dead when he got here." McCarthy said that the deceased, clad in dress and bloomers, was lying on a bed, and was partly covered with a torn blanket. The body was very unclean, and apparently had not been bathed for some time. It was lying on an old stained mattress, under which there was some dirty clothing. The room and the house generally were in a filthy condition, and not fit to be occupied by a sick person. "TOO MUCH TO DO." The witness said that he asked Mrs. Simpson why she hadn't removed her daughter to a place where she could have had proper care, and why she hadn't informed the police. She replied, "I sent my daughter to tell the police that Bertha was ill, and they didn't reply." Further questioned, she said that she had about £3 a week and support from her husband. Admitting that the place was dirty, she said, "I have too much to do." Having described the condition of the bed in question, Sergeant Swan said that there was no covering on the floor and no furniture in the room. The only food he saw in the house was stale bread. He asked Mrs. Simpson how long her daughter had been sick. She replied, "She came home from work about a fortnight ago. I sent for Dr. Blaxland or Dr. Champion last Tuesday week. I was told that the doctors were at the hospital. I asked would they tell them when they came back: but they didn't come." Further questioned, she

said that her daughter Kathleen rang for the doctor. She also said that Mr. Silverstone, when told that the girl was not well, advised her to ring Dr. Champion and mention his (Silverstone's) name; he also said that he would be responsible for any expense incurred. Dr. Dr. Sheldon, of Granville, said that, called to the house at 10 a.m., he found the girl dead. A post-mortem certificate by Dr. Cedric Whiting disclosed that death was due to broncho-pneumonia.

"KIOSK OPENED" NOLLER MEMORIAL Deep tributes to the late Alderman W. P. Noller were paid last Wednesday when the Noller Memorial Kiosk at Parramatta District Hospital was opened by Mr. G.. T. Erby, patron of the hospital and veteran colleague of Alderman Noller on the hospital-board. Built at a cost of £694, the kiosk will be used by the Ladies' Auxiliary for the sale of goods in aid of the hospital. The Mayor (Ald. Jeffery) who is president of the board, desribed Alderman Noller as one of Parramatta's greatest citizens. Alderman Noller, he said, was eleven times Mayor, was president of Parramatta District Hospital for many years, was an ardent church worker and an untiring supporter of the Minden Homes, Carlingford, and had done fine work as chairman of Parramatta Benevolent Society. "He set an example of citizenship that all might well emulate," said the Mayor. "He was a man of wonderful energy, and he died in harness". The Mayor added that £230 of the cost of the building had been contributed by the citizens of Parramatta and £349 had been granted by the Hospitals Commission. The balance was raised by the Ladies' Auxiliary. "The members of the auxiliary have worked for the hospital under extremely difficult

circumstances for many years, and they have raised some hundreds of pounds annually," he said. The Minister for Labor and Industry (Mr. Gollan) said that Alderman Noller had made a wonderful contribution of service to Parramatta and to Australia. "I had many opportunities of making contacts with Alderman Noller, and I never heard him say an unkindly word or heard of him doing an unkindly act," said Mr. Gollan. "He was loved by all who knew him, and the more you knew him the more you respected and loved him." Mr. Erby, who has been a member of the hospital board for 35 years, said that Alderman Noller had always given the best that was in him. Parramatta Appeal LADIES TO' ORGANISE COLLECTIONS That £1148 had been subscribed to the Parramatta fund to assist civilian war victims in Britain was announced by the Mayor (Alderman P. H. Jeffery) at Parramatta Town Hall last night-at a public meeting called for the purpose of furthering the appeal. The attendance was woefully small. It would have been much smaller but for the "LAMPS," who had assembled for their own meeting but decided to attend this one first. Honorary collectors were appointed for an intensive appeal within the next fortnight. And Mrs. Cedric Whiting will convene a meeting of ladies for the purpose of organising subsequent house-to-house collections. A small committee was appointed to consider Rev. I. A. Shaw's suggestion that portion of the money should be spent in the purchase of goods for despatch to Britain. On the platform with the Mayor were Bishop W. G. Hilliard. Rev. T. A. Shaw, Aldermen T. H. Harvey, R. A. P. Waugh, W. R. Musto, W. Cameron, and H. Vaughan. and the town clerk (Mr. L. N. Brown). "Lengthy speeches are quite unnecessary on an occasion like this," Bishop Hilliard said, "When we have before us an appeal that must stir everybody who has a drop of British blood in him. "The Motherland stands up. on behalf of civilisation and the future of the human race against the onslaught of those evil things with which Nazi Germany has beset herself. She stands as the champion of all that makes life worth living. Y. i, "MAGNIFICENT PEOPLE." "London is standing up to it magnificently. And one thrills as one thinks, not only of those gallant young heroes of the air, not only of the magnificent men of the Fleet. not only of the gallant troops; but also of those magnificent people--ordinary humble people-who are proving to Hitler that he Just can't break the morale of the British people. "We must show them that we really are behind them; that we really want to share some of the burden that they are shouldering." Announcing that £1148 had been subscribed since the appeal was launched on Friday week, the Mayor said that the Parramatta Mayoral Patriotic Fund committee had donated £100. "I think it's the desire of the council that this fund should be closed as soon as possible," he said. "We want to make it a short and sharp, appeal, and hope to close it. if possible, at the end of

next week," Emphasising the need for a more sustained effort. **Alderman Waugh** said that everybody should be given an opportunity to subscribe at a small amount regularly. On his motion **Mrs. Cedric Whiting**—from whom he had received the suggestion that house-to-house collections be made—was appointed to convene a meeting of ladies to organise such collections. As money was needed urgently for relief in Britain, it was decided to make an intensive effort to raise as much as possible within the next fortnight, and then close "the main fund." Mr. and Mrs. R.
